



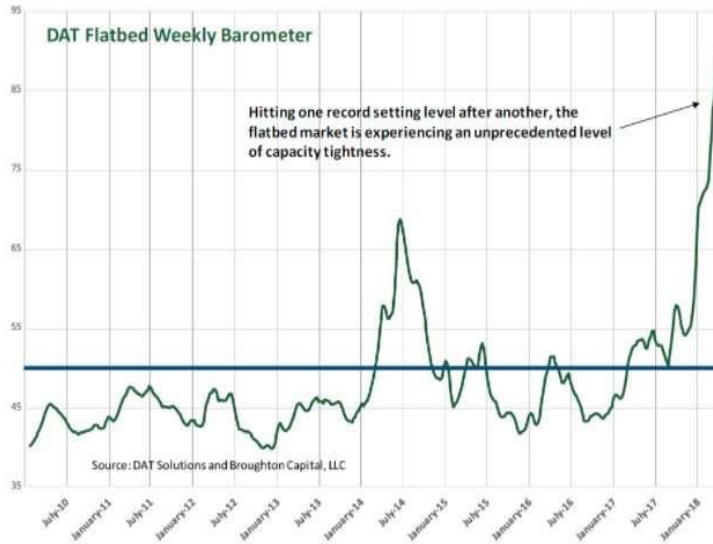

Subject: Energy Surcharge Announcement
Effective April 1, 2022

Effective April 1, 2022 due to the increase in energy cost and energy surcharges from all suppliers we purchase from, we have no choice but to add a 3.5% energy surcharge to every invoice total until further notice. For over two years, QDI Surfaces as a company has absorbed these additional costs. However, while we regret this notice, the escalating increases in energy costs have simply outpaced our ability to absorb these increases. We at QDI do not want to raise pricing in some cases we have recently lowered our market pricing to be as competitive as possible. This surcharge will allow us to provide great customer service you expect from QDI without a price increase. The charts below illustrate the increases in capacity driving energy charges up over the last two years.

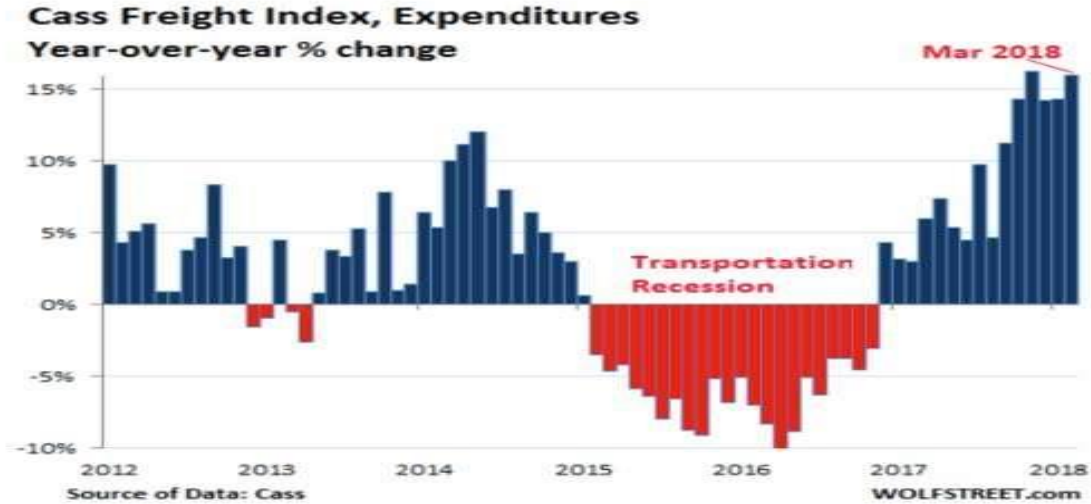
