1. PRODUCT INFORMATION: The information provided on our website, product descriptions, and marketing materials is for general informational purposes only. 2. VARIATIONS IN COLOR: (American Standards Testing Methods - ASTM C1527 4.4) Piece to piece variation within pallet and variations from production are expected, normal, natural, and accepted in tile and natural stone. Any installed natural stone materials are required by Natural Stone Institute to be blended from pallet to pallet during the installation process. For large projects all material should be on site prior to initiating installation. If this cannot be done, it is recommended that there be a designated area where the multiple shipments will meet so as to minimize the possible color variation effects.

3. VARIATION IN APPEARANCE: Natural stone, ceramic and porcelain tile and Primo Bella® Quartz products may have variations in color, texture, and appearance due to their natural or manufactured characteristics. Images displayed on our website and in our marketing materials are for illustrative purposes only and may not precisely represent the final product's appearance. We recommend viewing physical samples prior to making a purchase.

4. DAMAGED MATERIAL ON PALLETS: There is commonly 5-7% breakage within shipped pallets from worldwide ocean and land transportation. We inspect orders as they leave our yard for excess damages. If the material arrives at the job site with more than acceptable damage, it is due to shipping conditions from QDI Surfaces facility to your locale, as it did not leave our facility in damaged condition. Please make notes to the driver of the delivery vehicle. No claims will be accepted once an item leaves a QDI Surfaces facility.

5. VOIDS OR HOLES IN TRAVERTINE: (ASTM C1527 4.3) Voids and holes in travertine and limestone are normal and natural. However, we require factories to sort materials for the best possible selections, instances where material from same production containing a higher degree of pores is possible. These are accepted as normal and we display our material to be obvious about that possibility. Please be sure that samples and showroom displays contain these natural effects. Sorted material will not be returned to QDI Surfaces for any exchange or refund, the material if deemed unacceptable will be returned in whole with QDI Surfaces' pre-approval, or the material accepted in its entirety.

6. INSTALLATION AND MAINTENANCE OF ALL MATERIALS: Before beginning ANY project be sure to thoroughly read, and understand all precautions and warnings. QDI Surfaces provides general installation and maintenance guidelines for our products. However, we are not responsible for the installation process carried out by third parties. Users are advised to consult with qualified professionals for proper installation, maintenance, and adherence to local building codes. It is highly recommended to pre-seal back-side and all four-sides of the FRESKA Limestone materials with FILA PW-10 sealer prior to the installation if the said material is installed directly onto the soil. PW-10 is NOT a topical sealer! This will help minimize the risk of contamination in the soil to be absorbed by the material.

7. QDI SURFACES SPC FLOOR: This material is intended for indoor use only. Avoid exposure to direct sunlight for prolonged periods; doing so may result in discoloration. During peak sunlight hours, the use of drapes or blinds is recommended. Carefully check flooring material for any defects prior to installation and contact supplier immediately if any are found. 8. PRIMO BELLA QUARTZ: Like all natural stone countertops, quartz can be damaged by sudden changes in temperature. Pot holders and trivets should be used to protect a quartz countertop from anything hot. Though quartz countertops are not approved for outdoor use due to the manufacturing process, quartz may be used in outdoor kitchens with full overhead coverage from the elements. For deep cleaning make sure to use a neutral PH cleaner designed specifically for quartz-based engineered countertops and follow the provided instructions. When cleaning the surface of the pavers be sure to use a brush or broom with soft nylon bristles. Please refer to complete installation and maintenance guide.
